Actual individual transactions are approved by the Board of Directors and supervised through receiving a report. When the Board of Directors pass a resolution concerning related party transactions, a legal check is carried out by the department in charge of legal affairs. As part of such policies, appropriate measures are taken to protect minority shareholders when conducting transactions with controlling shareholders.
